Annual Subscriptions due by 1st April

FULL (SINGLE) membership is advisable for owners and breeders and any person wishing to vote at Annual General Meetings.

LIFE membership is a one-off payment, with full voting rights.

FAMILY membership gives Full membership to two adults + non-voting membership to two children under 18 years old in one household.

JUNIOR (to 18 years old) membership is non-voting.

OVERSEAS VOTING membership is for overseas members requiring voting rights

OVERSEAS membership is non-voting. Both fees include extra postage for overseas mailing.

New members joining after 1st December will not need to pay a subscription the following April.
