THE CASPIAN HORSE OF IRAN is unique, beautiful and very rare. Despite its pony size, the Caspian has the mind, build and smooth paces of a well-bred horse, highly intelligent, with a friendly and willing temperament. Although there are now Caspian lovers and breeders in many parts of the world - it is still a threatened breed and needs our help to survive.

Whether or not you are a member of the CASPIAN HORSE SOCIETY, you will probably agree that we must all do our best to protect the breed for future generations to enjoy, just as you have in your lifetime.

THERE ARE SO MANY WAYS that a generous gift from you could help us save the Caspian breed for our children and grandchildren to enjoy...

Your bequest could go towards the training and schooling of RIDDEN AND DRIVEN CASPIANS, to take part in show-jumping, pony-racing, dressage, gymkhana and school-work. They've already shown that they are the ideal narrow, comfortable mounts for small children and can be highly competitive. Caspians have also shown they can win at national level in scurry competitions, cross-country obstacle competition and driving classes, but training can be costly. Your support could help Caspians to compete successfully at top level again and bring the recognition that the breed deserves.

Every Caspian blood line is valuable - for the sake of this rare and special breed, the CASPIAN GENE POOL must be carefully preserved. CHS is raising funds to set up a GENE BANK, which will freeze-store semen from suitable stallions of the rarer bloodlines, keep it available to overseas breeders and ensure that no bloodline ever dies out. Generous bequests have already started the ball rolling, but more will be needed before we can begin collection, testing and semen storage.

CHS takes a display stand with live Caspians to shows around the country, to introduce and demonstrate the breed and raise awareness amongst new children and breeders. Your kindness could help us to reach more shows and put on a better display!

- (C) If at my death CASPIAN HORSE SOCIETY has changed its name or amalgamated with or transferred its assets to another body then my Executors shall give effect to any gift made to CASPIAN HORSE SOCIETY as if it had been made (in the first case) to the body in its changed name or (in the second place) to the body which results from such amalgamation or to which such transfer has been made.
