

## WHAT KIND OF MEMBERSHIP?

**Annual Subscriptions are due by/on 1<sup>st</sup> April**

**FULL** (*Single*) membership is advisable for owners and mandatory for breeders and any person wishing to vote at Annual General Meetings, UK only.

**LIFE** Membership is a one-off payment, with full voting rights. Overseas members pay a little extra towards postage costs.

**FAMILY** Membership gives Full Membership to two adults + non-voting membership to two children up to and including 18 years old, in one household in UK.

**JUNIOR MEMBERSHIP** (up to and including 18 years old) is Non-Voting, UK only.

**OVERSEAS VOTING** Membership gives voting rights to members outside UK.

**OVERSEAS** Membership is Non-Voting, for members outside UK. Both fees include an allowance for extra postage. O/S Family Membership is for two voting adults and up to two non-voting children up to and including 18 years, outside UK.

**Honorary membership is non-voting. New members joining after 1<sup>st</sup> January will not need to pay a subscription the following April.**

**All new applications must be ratified by Council.**

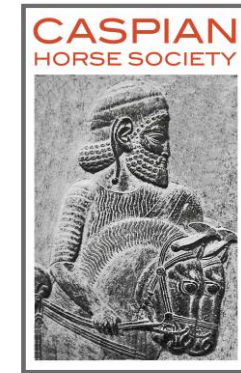
